ALTERNATES

1. GENERAL

All work included under this heading shall be subject to the General Conditions of the entire operation. The Contractor for this portion of the work is required to refer especially thereto.

2. ALTERNATES

2.1 **ALTERNATE NUMBER ONE**: Concrete Site Sidewalks

This alternate considers the additional cost to the Base Bid if the General Contractor installs reinforced concrete sidewalks. Refer to Sheet SP1.2 for scope.

2.2 **ALTERNATE NUMBER TWO:**

FEMA Shelter Windows and FEMA Window Shutters

This alternate considers the additional cost to the Base Bid if the General Contractor provides and installs FEMA Shelter Windows and FEMA Window Shutters. Refer to Drawings.

2.3 **ALTERNATE NUMBER THREE:** Sports Rubber Flooring

This alternate considers the additional cost to the Base Bid if the General Contractor provides and installs Sport Rubber Flooring. Refer to Sheet A8.1 for scope.

2.4 **ALTERNATE NUMBER FOUR:** Sewage Ejector

This alternate considers the additional cost to the Base Bid if the General Contractor provides and installs a Sewage Ejector. Refer to Plumbing Drawings for scope.

2.5 **ALTERNATE NUMBER FIVE:** Data Cabling

This alternate considers the additional cost to the Base Bid if the General Contractor provides and installs Data Cable. Refer to Electrical Drawings for scope.

2.6 **ALTERNATE NUMBER SIX:** Gas Line Relocation

This alternate considers that General Contractor shall recommend a dollar amount for a cash allowance in the Base Bid, for the General Contractor to remove the existing gas line, and provide, reroute as required and install a new gas line. Any unused amount will be credited back to the Owner at the completion of the project and before final payment is made. Refer to Drawings.

2.7 **ALTERNATE NUMBER SEVEN:** Asphalt Paving

This alternate considers the additional cost to the Base Bid if the General Contractor provides and installs asphalt paving. Refer to Drawings.

2.8 **ALTERNATE NUMBER EIGHT:** Metal Panel Wall System

This alternate considers the cost savings to change the full height face brick to a brick wainscot. The portion of the wall where the brick was deleted shall be covered with a prefinished metal wall panel. This price shall include all the materials and labor necessary. Refer to sheet A4.1a for additional information.

2.9 **ALTERNATE NUMBER NINE:** Tuck Pointing

This alternate shall include the unit price for soild masonry tuck pointing of the existing South, East, and West walls of the Gymnasium Addition; this alternate shall include a unit price per 50 square feet of solid masonry tuck pointing. Refer to attached drawing "B" being issued with this Addendum.
