The additions and/or corrections shall be considered as a part of the Contract Documents as if incorporated therein. Where the following corrections and/or additions vary from the conditions of the Drawings and Specifications, such following changes or additions shall govern.

I. GENERAL CLARIFICATIONS:

1.1 Bid Date:

The bid dates will remain:

The bids for Colby are due on or before Thursday, January 20, 2022 at 3:00 p.m. The bids for Russell are due on or before Tuesday, January 18, 2022 at 3:00 p.m.

- 1.2 The successful bidder will be responsible for providing a cost break-out of the following items:
 - A. EV Charger Stations
 - 1) Concrete
 - 2) Bollards
 - 3) Electrical
 - 4) Installation
 - B. Bio Tank and E98 Tank Installation
 - 1) Excavation
 - 2) Backfill
 - 3) Concrete
 - 4) Electrical
 - C. COLBY The owner would like to have the successful General Contractor prepare a detailed cost break out for the Mokas Café & Bistro.
- 1.3 Glass Types:
 - a. There is some discrepancy in the glass types shown on the building elevations and specifications (Section 8800-Glass and Glazing). As such we are reissuing the Glass and Glazing Schedule.
- 1.4 Backfill Requirements (new Fuel Tanks)
 - a. The backfill for the new fuel tanks will be by the Petroleum Contractor (a separate contract to the owner). This addendum includes the Xerxes (Fuel Tank Manufacturer) backfill instructions for information.

1.5 Sub Base Clarification

Addendum 3 addressed the three options available (item 4.1 (c)). The minimum thickness shall be 12". The soils report discusses the use of LVC if properly conditioned and compacted; this option only applies only under the building, not the paved areas.

1.6 Dog Park Locations

a. Colby

The dog park is south of the McDonald's

b. Russell

The dog park is on the SW corner of the property.

II. CHANGES TO SPECIFICATIONS:

- 2.1 Section 08300 Sliding Automatic Entrances (Colby + Russell)
 - a. Paragraph 14.2 Framing Members
 The item numbers shall be corrected; item 14.1.1 shall be 14.2.1; item 14.1.2 shall be 14.2.2.
 - c. Paragraph 14.3 Stile and Rail Doors and Sidelights
 - 1. The item numbers shall be corrected; item 14.2.1 shall be 14.3.1; item 14.2.2 shall be 14.3.2; item 14.2.3 shall be 14.3.3; item 14.2.4 shall be 14.3.4; and 14.2.5 shall be 14.3.5
 - 2. Item 14.2.2 (which was corrected to be 14.3.2) The Stile Design, shall be corrected to be **Wide Style** as noted in item 12.2.1.
- 2.2 Section 08400 –Entrances And Storefronts (Colby + Russell)
 - a. Paragraph 4.5 shall be clarified to be Manko 2450 FS Series Storefront (thermally broken), front set.
 - b. Paragraph 12.2 Doors All the aluminum doors shall be clarified to be Wide Style
- 2.3 Section 08700 Door Hardware (Colby + Russell)

The Door Hardware Sets Schedule shall be corrected and re-issued to be as follows:

- a. Both Colby and Russell Hardware should be the same for both buildings. Similar doors for each shall use the same hardware.
- b. All employee entry spaces are to be keyless.

c. Colby - Hardware Set 4.0 shall be modified and re-issued, with the Entrance or Apartment Lock being removed/eliminated from the hardware set list, so that Hardware Set 4.0 shall be as follows:

2.4 Section 10800 – Toilet Accessories

Paragraph 7 – Toilet Accessories, the introductory paragraph will be deleted the following portion - "All equipment shall be provided by the Owner and installed by the General Contractor (G.C.) excluding grab bars, and glass mirror, which will be provided and installed by the G.C."

This main paragraph shall now read as follows:

Manufacture shall be as specified, or the approved equal.

2.5 Section 08800 – Glass and Glazing (Colby + Russell)
The Glass Schedule shall be corrected, and is re-issued to be as follows:

SCHEDULE: NEW CO-BRAND CONVENIENCE STORE:

- 12.1 Glass Type 1: 1/4-inch float glass, gray; tempered as required.
- 12.2 Glass Type 2: 1/4-inch float glass, clear, tempered as required.
- 12.3 Glass Type 3: Not Used.
- 12.4 Glass Type 4: 1/4" "Mapes" Porcelain panel, finish (2) sides.
- 12.5 Glass Type 5: 1" insulating glass consisting of two (2) 1/4" float glass lights with air space tempered as required. Clear.
- 12.6 Glass Type 6: Not Used.
- 12.7 Glass Type 7: 1" insulated spandrel glass, gray; (1) 1/4" float glass spandrel light outer pane and 1/2" rigid insulating spacer and 1/4" hard board inner panel ready to receive paint.
- 12.8 Glass Type 8: 1" insulated "Mapes" porcelain panels, finish (1) side. Color from manufacturer's standard colors.
- 12.9 Glass Type 9: Mirrors shall be 1/4" float glass, Number One quality; all in sizes and locations as indicated on the Drawings.
- 12.10 Glass Type 10: Not Used.
- 12.11 Glass Type 11: Provide and install as shown on plans, 1/4" Firelite Plus glass for 2-hour assembly.

 For Russell: This glass is to be installed in opening 203a (Door and sidelight).
- 12.12 Glass Type 12: 1" insulating glass consisting of two (2) 1/4" float glass lights with air space tempered as required, low E. Standard grey, SolorBan 60.

III. CHANGES TO DRAWINGS:

3.1 Sheet A2.3

a. Roof Plan, Moka portion.

Provide and install a new factory formed, slip resistant, walkway pads made from roofing membrane material, installed on the roof surface from the roof access ladder, around all mechanical and electrical equipment. Install per the manufactures's instrction, solidly secured to the roof.

b. Refer to the Moka package, Sheet A5 for additional requirements.

3.2 Sheet A3.1 – Colby

a. This sheet is being reissued to correct the glass types shown on the frames. The sheet can be downloaded from our web page www.haarchitects.com then click on "Shortcut to Plan Room".

3.3 Sheet A3.1 – Russell

- a. Door Schedule opening 114a shall be changed to be 115a.
- b. Frame "3F" is not used on this project and shall be deleted.
- c. This sheet is being reissued to correct the glass types shown on the frames. The sheet can be downloaded from our web page www.haarchitects.com then click on "Shortcut to Plan Room".

3.4 Sheet A3.2 – Colby

- a. Frame "N", the glazing is specified as tempered 1/4" clear glass. This glass has been used at the other 24/7 stores without an issue. At this time we do not see a need to change it.
- b. This sheet is being reissued to correct the glass types shown on the frames.

3.5 Sheet 3.2 – Russell

- a. Frame G', the spandrel glass does not include a "Mapes" panel and shall remain spandrel glass as specified.
- b. Frame "N", the glazing is specified as tempered 1/4" clear glass. This glass has been used at the other 24/7 stores without an issue. At this time we do not see a need to change it.
- c. This sheet is being reissued to correct the glass types shown on the frames.

- 6.2 Sheet E1.0 Colby + Russell
 - a. Add fixture "C" to Light Fixture Schedule. Manufacturer: GM Lighting; Model: S4-3080-WH.
 - b. Add fixture "A4" to Light Fixture Schedule.
 2' x 4' Architectural LED Troffer, Columbia Lighting, LCAT24-40HLG-EU-ELL14,
 4300 Lumens, 4000K,UNV, lay-in, connect emergency (battery) to an unswitched, hot connector.
 - c. Sheet E1.0 for Russell has been reissued and can be downloaded from our website www.haarchitects.com; then click "Shortcut to Plan Room".
- 6.3 Sheet E1.2 Russell

Panel "C", this panel is detailed as 14k AIC rated panel. The breakers with switched neutrals are only 10k rated, so this panel can be changed to a 10k AIC panel.

- 6.4 Sheet E1.3 Colby + Russell
 - a. The Quazite box size shall be 24" x 24"x 12", with open bottom.
 - b. The requirement was removed for concrete encasement on the building feeder.
 - c. A shunt trip was added to the main breaker and an exterior mounted push button was added.
 - d. These sheets for both Colby and Russell have been reissued and can be downloaded from our website www.haarchitects.com; then click "Shortcut to Plan Room".
- 6.5 Sheet E4.1 Russell
 - a. The Low Voltage plan was modified.
 - b. These sheets for both Colby and Russell have been reissued and can be downloaded from our website www.haarchitects.com; then click "Shortcut to Plan Room".
- 6.6 Moka Sheet E1

Light fixture schedule to include fixture "P".

Manufacturer: GM Lighting; Model #: V120-RGBW-XX; Controller: SHWC-V120-RGBW. This correction is not shown on the new stamped set of drawings issued with this addendum.

6.7 Moka - Sheet E3

Add one "W" light fixture above the rear exit door.

This correction is not shown on the new stamped set of drawings issued with this addendum.

6.8 General Comments

- a. Will concrete be removed to allow conduit feeds to the new light poles?
 The concrete paving will be removed to provide access to the new light poles and street sign.
- b. If the alternate for EV loaction is selected, will future ground boxes be required?
 Colby no alternate location.
 Russell if the alternate for EV chargers is selected (under the canopy), then add future boxes to the alternate with the chargers on the north side of the building.
- c. The Electrical Contractor is to supply all wiring. The plans call out what devices the Owner is installing (refer to note 6 on sheet E4.1 both Colby and Russell; also refer to EQ-1 and EQ-2).
- d. The service connection fees levied by the City (Colby and or Russell) shall be paid for and included in the Base Bid.
