# I. GENERAL CLARIFICATIONS

1.1 Bid Date.

- 1.3 Products or manufactures approved, as "Equals" shall meet all requirements of the plans, specification, standards of performance and construction as established by the product or manufacture originally specified.

2.1 Sheet C.10

2.2 Sheet SP1.3

# 3. CHANGES TO THE SPECIFICATIONS

- 3.1 Section 00300-Special Conditions
  - a. Paragraph 23, the word "Fax" shall be deleted from the title.
  - b. Paragraph 30 Temporary Heating and Cooling, item 30.1, add the following sentence:
    If used during construction, the ducts and equipment shall be cleaned and all filters replaced.
  - c. Paragraph 31 Temporary Water and Sewer; delete the following sentence: If used during construction, the ducts and equipment shall be cleaned and all filters replaced.
- 3.2 Section 08113 Hollow Metal Doors and Frames
  - a. Mesker Hollow Metal Frames and Doors is an approved manufacture. Refer to item 1.3 in this addendum.
- 3.3 Section 08200 Wood Doors
  - a. Eggers Wood Doors is an approved manufacture. Refer to item 1.3 in this addendum.
- 3.4 Section 08340 Roll-Up Grille
  - a. The finish shall be clarified to be powder coat paint, with the color selected by the Architect from the standard color options.
  - b. The roll-up grille shall be clarified to be an overhead coiling slates in lieu of a mall style grille.
  - c. The unit shall be motorized and tied into the fire alarm system. The electrical contractor shall provide power.

- d. Paragraph 1.1 Summary, item 1.1.3 shall be corrected to be (1) unit to be installed at the school office as part of the Security upgrade. Refer to Sheet A1.3
- e. The coiling door shall be 30" wide by 3'-10" tall (field verify the actual size before fabrication).
- f. The assembly shall have a 60-minute fire rating.
